Dance Report 2021

In March we were back in the hall wearing masks and using Humanitix for tickets. Worked well we also Zoomed this dance. We did our Zoom dance on the third Saturday.

April due to Easter we didn't have a dance on the first Saturday but still did our third Saturday Zoom dance. We have been using the third Saturday Zoom dance as a Theme dance which is working quite well. Norm and I being the callers and Stephen running the sound. We also ran our first Children's dance for the year in April, which was a big success. We were able to pay the band!

In May we were still in the hall for the first Saturday. Again in the hall for the Children's dance again another success.

We were also able to run our first Woolshed Ball for 2 years in the hall, with the talented club musicians playing. We even had a BYO supper.

June has not been so kind to us we had the June first Saturday dance via Zoom due to Covid-19 restrictions and we had to cancel the Children's dance for the same reason but we didn't Zoom it.

I would like to thank all the people who have helped with the Saturday dances and the Woolshed ball. These include: being on the door, helping in the kitchen, decorating the hall and the callers and musicians who have made each event a success.

I have been very fortunate in having a core of people who have been very willing to do their bit to make the dances happen; thank you and I sincerely hope you are happy to continue doing your contribution as it has made my task so much easier.

We had amazingly a very good Wattle day on Zoom in 2020 having quite a variety of workshops for musicians, singers, dancers and computer geeks. Our thanks go to the Wattle Day committee, workshop conveners and to all the patrons who attended as without your attendance we would not have had such a successful Wattle Day.

Concert Night Report for 2021 AGM

The last 12 months has not been an easy one for the club when it has come to running our concerts. The concerts restarted in Sept 2020 with the duo Drop o' Scotch. This was our first attempt at running a virtual concert & despite some minor teething issues it was quite successful due in no small way to the technical expertise of some of our members. We continued with virtual concerts up until May this year when we had the lively trio (+ two extras) The Jam Tarts. This was our first concert in our new hall (Ringwood Uniting Church hall) which presented a couple of problems none which were

insurmountable. As well as being a live performance we also presented it as a virtual concert for people who lived interstate or didn't feel comfortable in meeting in a crowd. As the new hall is very different to our old one we are still experimenting with different layouts to see which one will give the best audience experience.

Due to Covid restrictions on numbers of people attending an event we have had to make it "tickets by on-line booking only" so we can control the numbers attending.

Just when we thought we were ready for our June live concert we were thrown into confusion by another snap lockdown. The artist we had booked wasn't able to perform via Zoom due to technical issues but very fortunately Bruce Watson stepped in with only a few days notice. Due to Bruce's popularity both in Australia & the United Kingdom we sold over 90 tickets. As a result of that concert we have had a regular attendee from the UK at each of our Tuesday session nights since.

Following the snap lockdown in June we have had to be mindful of the possibility that partial lockdowns can happen at short notice so we have had to factor that into our decisions on who our guest artists are and if we would need to change artists at short notice,

NEWSLETTER REPORT FOR AGM 4/7/2021


This past year has been probably the weirdest of all since I took over as editor of the VFMC newsletter in about 2012 – due obviously to the coronavirus pandemic.

President's Report 2021

I am pleased to report that despite the impacts of the pandemic, your club remains active and is well positioned to resume "normal operation" whenever that becomes possible.

The response of your committee and its sub committees to the challenges of the last year has been admirable. The team has worked together, showing resourcefulness and adaptability to quickly adjust to the issues that continue to confront us.

Financially, the last year has been difficult. Our financial reserves have kept us going, and prudent management has resulted in a manageable deficit.

Over the past year, our membership has been kept informed, has been entertained, and to a large extent is still engaged with the various activities of our club. Mainly, this has been achieved through the use of Zoom technology.

Zoom is in no way comparable to the pleasure that our face-to-face activities provide, but we have socialised and made music together, we have continued to support the performers who make our concerts possible, while providing quality folk music entertainment, and we have even supported physical activity for those members who like to dance. An unanticipated benefit of our on-line presence has been the expansion of our sphere of influence both nationally and internationally. During the year, we have been joined by folkies in the USA, Canada, UK and Switzerland, and from around Australia.

Even within Melbourne, on-line activities have enabled participation by people who would not normally wish to travel to our live events. We have decided to continue with what we now call 'hybrid' events, face-to-face events backed up by Zoom access for those who cannot, or don't wish to travel. We currently expect to continue with hybrid events after pandemic restrictions ease, as long as there is a reasonable demand.

Early this year, we relocated our web site to a commercial hosting service. See the Webmaster's report for details. We thank Jeeves Audio Services who have made on-line space available to us for several years.

Some of our members have been confused by the change to our membership year. This change was voted in at the 2019 AGM, and after much planning, was implemented over the last 15 months. The cost of this change contributed to this year's deficit. Please note that all memberships are now due for renewal each year at the end of March.

Sadly, we lost two valued members of our club in the last year, both to non-Covid illnesses. Both had served on our committee. Don Gingrich had been a very active member of the Billabong Band, and Greg Woodruff played a major role in the Joy Durst Songbook revision. We miss them both.

Finally, I wish to thank all the committee and sub committee members, and all the other club members who have worked so hard this year to keep us going. Of particular note are Bill Buttler for his work on Zoom, and Wal Tiedman for work with the VFMC Library.

Treasurer's report to AGM 4/7

The past year has been an abnormal and disruptive year for the Club. The Covid19 pandemic caused the Committee to suspend all activity involving face-to-face contact, including meetings. With the uncertainty of how long the initial lock-downs would continue tests were conducted into replacing regular face-to-face activities with weekly on-line meetings, which proved to be beneficial in keeping the continuity of the Club going and the members in contact with each other.

With the cancellation of physical activities rent costs declined, as did surpluses from activities and donations from Concert Party gigs. Concert dates by several previously booked performers were cancelled so the Club payed a cancellation fee. Interest earned from the term deposits is also declining over time.

The finances are being audited by Dainbridge Accounting and their report will be on the website. Shortly I will ask the meeting to accept the Treasurers Report. There no outstanding issues, no un-presented cheques, all bills have been paid in a timely manner, and reports have been presented to the Committee each month.

The EOFY income over expenditure for the year shows a cash deficit of -\$1,603.52. A transfer of \$4,000 from a Term deposit was made on 10th July to bolster the Trading account which was gradually declining due to activities being suspended.

Interest from the two Term deposits returned \$270.73 and \$1,673.30, totalling +\$1,944.03.

Total cash balance (Trading account and the two Term deposits) at EOFY is \$63,314.31. After the auditor applies depreciation to stock and equipment the net assets of the Club should be little more than this.

Due to healthy reserves in the bank before the pandemic arrived the Club has been able to weather the challenges, and I expect a return to some sort of normalcy as things pickup again. I do not recommend any increase in membership fees or admission charges for the coming year.

We played at the VFMC Christmas Dance however the afternoon Senior Citizens Dinner/ Concert was cancelled.

We also played a zoom dance which was well received, and played live at the May Woolshed Ball, which was another very well received event. What was disappointing at these dance gigs was the limitation on the number of musicians due to COVID density rules, both on stage and also at rehearsals.

The best opportunity for most of the musicians to play was at the children's dance in April. We had an eager turn-out of players and a happy lot of young dancers.

We did manage a get-together and a rehearsal for the Billabong Band at Stewart Boundy's house in March. Many thanks to Stewart for his hospitality.

On the plus side, the Billabong Band has been accepted to play a concert at this year's Maldon Folk Festival on the Melbourne Cup weekend. The concert title is "Don's Empty Chair", and is a memorial to Don Gingrich who passed away from an aggressive illness almost a year ago. Don had arranged a concert at last year's festival, which ended up being cancelled, and knowing he probably wouldn't last til the event, asked for an empty chair to be put on stage.

We look forward with fingers crossed to lost and delayed bookings and events being available to us between now and next year's (2022) AGM.

Sessions Report to AGM 4/7/21

Living with the Covid pandemic has been the central theme to everything the Club attempts, but despite the unvoidable upsets Tuesday Sessions have continued to be

weekly highlights of enjoyable music making and social interaction.

Facing the uncertainty of how long the lockdowns and disruption would last the Club early got on to providing an online mechanism to allow Sessions to continue. Using Zoom it has been possible to reach people anywhere, and we soon found 30-40 logging in each week. The continuity of the Club has been maintained throughout and thanks to the technical expertise of our people, and the patience and toleration of everyone else, both live and on-line attendance is now possible with a good degree of success.

Attendances are typically around 20-24 spread over both in-hall and online. The wide range of interests and the expertise of members is very stimulating; the quality of the music and verse and discussion virtually always makes for a high value couple of hours spent each week. That more members are stepping up to do spot acts at Concerts or involvement in the Billabong Band is good to see too.

The technical team recently obtained a laptop and are in the process of installing much of the Club's resources onto it so they can be webcast or projected at will. The importance of this is considerable as it dispenses with the very large amount of messy books and music stands we used to live with, including the storage of all this stuff.

Continuing development of the website has been a great help too, as members can now get easier access to information and resources. The updating of the ever-changing situation caused by the virus can now happen rapidly.

Changing halls halfway through the year has been a good move as well, the Ringwood Uniting Church is more central, roomy and prominent.

On behalf of the Sessions Sub Committee I thank Ray and Joan Mundy, and Kate Cotril, for running the song and tune sessions each week; the technical people for getting the Zoom up and going; the Covid management team for looking after disinfection etc.; the web team for a sterling job there too. Thanks also to the membership who willingly share their talents and musical experiences, making VFMC Tuesday Sessions a stimulating time to look forward to each week.

Last winter, the committee decided to move the club web site to a new hosting arrangement on a commercial footing. We thank Jeeves Audio Services who have provided free hosting for the past several years.

The committee also decided, wisely as it turns out, to make the change in January when club activity is at its least. We prepared for the move, then went ahead in January. Perhaps our hosting supplier was short staffed during the holiday period, but their support for the changeover was woeful. There were some outages when either the web site and/or

email services were unavailable. Our web team worked very hard to resolve numerous issues, and everything was brought under control and is now functioning well.

Part of the planning for the move involved standardisation of several technical aspects of the web site which had grown somewhat haphazard over the years. This standardisation has proved valuable in facilitating several enhancements this year. One major part of the web site, the Fireside Fiddlers music collection, built by the late Harry Gardner, remains to be tidied up. This collection consists of thousands of web pages and scores and sound files, built to at least three different design approaches. There are also many obsolete file versions, technical errors and broken links. The web team are working on a conversion and clean-up programme which will take considerable effort to complete. This is all being done with respect to Harry's vast effort in putting Fireside Fiddlers together, and the aim to keep his legacy for the future benefit of VFMC members and the broader folk music community.

Several innovations this year include integration of the Humanitics ticketing system into our events, introduction of PayMate as a means of membership payment, and the Tune Finder function which supports the search for tune/song titles and their related score/ sound resources both within the VFMC web site and externally.

Visitors to the web site will have noticed recent changes to the menu structures. More enhancements to the useability of the web site are in the pipe line, so watch out for them in coming months.
